THE TOWNSHIP SUPERVISOR AND BOARD OF TRUSTEES regularly scheduled Board Meeting held via video conference in accordance with Senate Bill 2135 due to pandemic concerns on July 21, 2020.

1. Supervisor O’Grady called the December 15, 2020, Regular Board Meeting to order at 6:45 p.m.

5. Public Comment: Mary Hastings read comment submitted by resident Marie Fuesel from the American Red Cross. Marie, a blood cancer survivor and advocate for blood donation, approached Supervisor O’Grady in March as she was unable to secure a location for permanent blood drives. The Township offered their facility and subsequently held five emergency blood drives due to the pandemic. Marie thanked the Board and staff of Orland Township for their support. As a result of the successful monthly blood drives held at Orland Township, the ABC7 Greater Chicago Blood Drive added Orland Park as a 5<sup>th</sup> location on air. Marie commends the Township for all they do for their residents.

  - a. Supervisor’s Report – Health Services is ready to assist in vaccinating if called upon by the State or County. They have formed the Orland Township Strike Force and registered as an iCare facility since October. Orland Township is committed to making sure the level of service is provided that the residents deserve and expect.

An advisory referendum was passed in Orland Park for term limits. The Board heard you, the voters, and will vote this evening to add a term limit referendum to the April ballot.

Additionally, the Board realizes Covid19 has greatly impacted our lives and will vote later tonight to keep our tax levy flat.
