CASE MANAGEMENT ORDER

On January 11, 2021, the duly constituted Township Officers Electoral Board of Orland Township (the "Electoral Board") convened to hear and pass upon the objections to the nomination papers filed in this matter. Appearing at said hearing was the Objector, through counsel and the Candidate, through counsel. The hearing was held via electronic means via Zoom Video conferencing pursuant to state law and the declaration of an emergency and the unfeasibility of an in-person meeting due to the COVID-19 pandemic. At said hearing, the Electoral Board accepted the recusal of Paul O'Grady as the chairman of the Board and the substitution of Paul O'Grady by the second longest sitting trustee, namely Maria Sanfilippo; adopted the Rules of Procedure; and set a briefing schedule for the Candidate's Motion to Strike and Dismiss and Candidate's Motion to Disqualify, which were filed instanter by the Candidate.

The briefing schedule for the motion to strike and dismiss is as follows:

- 1. The Objector shall have until Friday, January 15, 2021 at 5:00 p.m. to file a response to the Candidate's motion to strike and dismiss, if any.
- 2. The Candidate shall have until Monday, January 18, 2021 at 5:00 p.m. to file a reply to the Objector's response to Candidate's motion to strike and dismiss, if any.

The briefing schedule for the motion to disqualify is as follows:

- 1. The Objector shall have until Thursday, January 14, 2021 at 5:00 p.m. to file a response to the Candidate's motion to strike and dismiss, if any.
- 2. The Candidate shall have until Friday, January 15, 2021 at 12:00 p.m. to file a reply to the Objector's response to Candidate's motion to strike and dismiss, if any.

The Electoral Board further scheduled this matter for an examination of the voting records maintained by the Cook County Clerk and the Electoral Board directed its attorney to contact the Cook County Clerk to schedule said records examination.

The hearing for the motion to disqualify is scheduled for **Friday**, **January 15**, **2021**, **at 5:00 p.m. via Zoom**. Status on the scheduling of the records examination will also be given at said hearing. The link and information for the Zoom hearing is as follows:
