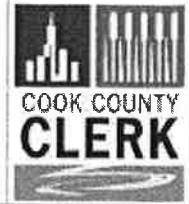

**TAX LEVY ORDINANCE**

**ORLAND TOWNSHIP**

**ORDINANCE No. 01-12-15-15**

An Ordinance levying taxes for all town purposes for Orland Township, Cook County, Illinois for the tax year 2015, collectible in 2016.

NOW THEREFORE, BE IT ORDAINED by the Supervisor and Board of Trustees of Orland Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of Two Million, One Hundred Sixty Three Thousand, Seven Hundred Seventy Seven Dollars (\$2,163,777.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Fund;

Audit Fund;

Insurance Fund;

Illinois Municipal Retirement Fund;

Social Security Fund; and

General Assistance Fund

for the year 2015.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


