Pat Connelly explained the shares were acquired from Principal Life Insurance who had issued shares to all policy holders. Orland Township had received 2000 shares plus dividends for the last ten years. Last year's audit recognized the asset and, following the instruction of the auditor, it was agreed to sell when fiscally prudent to do so. The current value is estimated at \$126,000.
