

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 02-12-19-22

An ordinance levying taxes for all road purposes for Orland Township Road District, Cook County, Illinois, for the tax year 2022 , collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Orland Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of One Million One Hundred Nintey-Six Thousand One Hundred Fifty-One Dollars (\$1,196,151.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:



on or before the last Tuesday of December, a duly certified copy of this ordinance.


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is
necessary to be raised by taxation for road purposes for Orland Township Road District.


SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be
