

TAX LEVY ORDINANCE

ORLAND TOWNSHIP

ORDINANCE No. 01-12-20-21

**An Ordinance levying taxes for all town purposes for Orland Township, Cook County, Illinois
for the tax year 2021, collectible in 2022.**

**NOW THEREFORE, BE IT ORDAINED by the Supervisor and Board of Trustees of Orland Township,
Cook County, Illinois, as follows:**

SECTION 1:

**That the sum of Two Million, Six Hundred Fourteen Thousand, Three Hundred Fifty Five Dollars
(\$2,614,355) are hereby levied upon all property subject to taxation within the Township
as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities
of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:**

General Fund;

Audit Fund;

Insurance Fund;

Illinois Municipal Retirement Fund;

Social Security Fund; and

General Assistance Fund

for the year 2021.

That the amount levied for each object and purpose shall be as follows:




SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
