- 5. Reports:
  - a. Supervisor O'Grady gave an update regarding the Cook County Zoning Mattter 17101 S. Wolf Rd. Stated there is a petition online if anyone would like to sign it. Took an informal survey of the citizens in attendance to gage if they wanted the Township to continue fighting this. Most in attendance affirmed their to desire by a show of hands.

Trustee Duffy reported that CERT will be started on September 18 and that more information is available on the website or by contacting him. He also reported that the finance committee meeting are postponed until a finance director is hired. He requested that Youth Services put more information into their report and pointed out that the food pantry is now prohibited from asking for the addresses of patrons of the facility per order by the Governor.
